- Discussion of "Special Use Permits" for C & T Smith:
 - "Special Use Permit" Clark & Tammy Smith
 - Hasn't been invoiced for the Special Use permit, our Clerk will work to get it completed by first or second week in August.
 - Current fee schedule states, "Actual Costs." It's been recommended, the Township Board should change this to an actual fee. If this is not acceptable, the Board should direct their questions to the Township Attorney. There are four (4) permits on the fee schedule that state, "Actual Cost". These should have a dollar value instead of stating,

"Actual Costs." To help the Board determine costs, consider the cost to the Township for the following:
